In Exchange for Team Chiacchia. providing care, custody and control of said horse which includes feed, hay, water, grooming, hand walking, lease of two test mares [for stallions], all State required C.E.M. cultures and procedures performed by approved Veterinarian, presenting said horse for inspection to required State agents, and representing owner's interest with said State and Federal Agencies, the undersigned horse owner hereby agrees to the following:

1. Payment of \$_____ for duration of C.E.M. quarantine
2. Owner will maintain insurance equal to the full value of said horse for the duration of the period that said horse is under care, custody and control of Team Chiacchia, and agrees that Team Chiacchia's full liability in the event of death or injury is limited to one hundred dollars [\$100.00]
3. Owner will be responsible for excess board. mares staying in excess of 21 days will be billed \$60.00 per day and stallions staying in excess of 42 days will be billed \$80.00 per day and \$60.00 per day for each test mare.
4. Owner will be responsible for all veterinary, farrier or miscellaneous expenses incurred for said horse.
5. Owner has received a copy of Team Chiacchia rules and agrees to follow them at all times
6. Owner expressly assumes all liability for or on account of any such injury, loss or damage to said horse during the

time said horse is in the care and custody of Team Chiacchia.; and will at all times indemnify and hold Team Chiacchia, it's agents, officers, directors, and employees harmless from all liability, suits, demands, loss or damage of any nature, including attorneys' fees, including those arising from Team Chiacchia, it's agents, officers, directors, and employees' negligence, gross negligence and/or will misconduct incurred or caused by or arising out of any such injury, loss or damage to said horse.

7. Owner expressly assumes all liability for or on account of any injury, loss or damage to Team Chiacchia facilities caused by said horse, and will at all times indemnify and hold Team Chiacchia, it's agents, officers, directors and employees harmless from all liability, suits, demands, loss or damage of any nature, including attorneys' fees cause by said horse
